Authorized use shall be defined as follows / Uso autorizado se define de la siguiente manera:

- ◆ **Students must keep cell phones/mobile electronic devices OFF and in their book bags while on campus between the hours of 6:30 a.m. –6:00 p.m. Estudiantes deben mantener teléfonos celulares/o equipo electrónico apagados y en su mochila mientras estén en la escuela durante las horas de 6:30 a.m. – 6:00 p.m.**
- ◆ **Use of cell phones/mobile electronic devices is NOT permitted during lunch time. El uso de teléfonos celulares/o equipo electrónico no está permitido durante la hora del almuerzo.**
- ◆ **Students MAY NOT enable or use the camera or photo features of the cell phone device to take any pictures on campus. Los estudiantes no pueden activar o utilizar las funciones de foto del teléfono celular para tomar fotos de nada ni nadie en la escuela.**
- ◆ **Administration requires the device to be registered with the school prior to allowing a student to use them in the manner described above. Administración requiere que el dispositivo o equipo esté registrado con la escuela antes de permitir a los estudiantes a utilizarlo en la forma descrita anteriormente.**
- ◆ **The school SHALL NOT be responsible for lost or stolen communication devices. La escuela no será responsable por la pérdida de equipos electrónicos.**

First Time Offense Consequences

- ◆ **Any UNREGISTERED or NON-APPROVED cell phone/mobile electronic device found in a student's backpack will be confiscated by school Administration and will require parental pickup.**
- ◆ **Students may not have a cell phone/mobile electronic device ON during the hours of 6:30 a.m. – 6:00 p.m. Cell phone/mobile electronic devices found on during these hours will be confiscated by school Administration and will require parental pickup.**
- ◆ **Students may not have a cell phone/mobile electronic device in their immediate possession, in their clothes pockets or outer garment pockets during the hours of 6:30 a.m. – 6:00 p.m. Cell phone/mobile electronic devices found in these locations during these hours will be confiscated by school Administration and will require parental pickup.**
- ◆ **Students who use a cell phone/mobile electronic device to take pictures and/or post such pictures on the Internet will be subject to Out of School Suspension and/or Expulsion from Imagine Kissimmee Charter.**

Multiple Offense Consequences

- ◆ **Any UNREGISTERED or NON-APPROVED cell phone/mobile electronic device found in a student's backpack multiple times will be confiscated by school Administration and will require parental pickup. In addition each offense will be subject to further consequences as described on the Osceola County Matrix of Infractions Consequences. Student may also be denied the privilege of having a cell phone/mobile electronic device at school.**
- ◆ **Students may not have a cell phone/mobile electronic device ON during the hours of 6:30 a.m. – 6:00 p.m. Cell phone/mobile electronic devices found on during these hours multiple times will be confiscated by school Administration and will require parental pickup. In addition each offense will be subject to further consequences as described on the Osceola County Matrix of Infractions Consequences. Student may also be denied the privilege of having a cell phone/mobile electronic device at school.**
